

Public Health Groups Oppose the Proposed Public Charge Rule

The proposed public charge rule would deny millions of people access to basic services that are the bedrock of the public health infrastructure. The proposed public charge rule seeks to limit programs and resources that have demonstrated evidence-based, positive impacts for the public's health. If implemented, the public charge rule would limit access to critical public health services for millions of people and set the stage for a public health crisis.

Why does <u>public charge</u> matter for public health?

- Driving people away from health care, nutrition services and affordable housing could have drastic effects on the public's health.
- There will be worse health outcomes as people delay or forgo care and disenroll from public benefit programs. This will lead to an increased prevalence of obesity and malnutrition; reduced prescription adherence; higher rates of poverty and housing instability; and reduced education attainment.
- There will be higher costs to the public health system, as immigrants disenroll from public benefit programs and turn to emergency departments to treat preventable illness and chronic disease complications.
- Parents may not vaccinate their children, increasing the risk of disease outbreaks and jeopardizing herd immunity, threatening the health of newborns, elderly, and individuals with comprised immune systems.
- Communicable and sexually transmitted diseases may go undiagnosed, and untreated leading to spread of the disease and preventable complications, including infertility.
- Pregnant women may delay or forgo needed medical attention endangering themselves and their unborn children.
- The proposed changes are detrimental to the public's health as a whole, but the effects will be particularly harmful to children who will face the impacts across their lifespan. Traumatic experiences, including a lack of access to healthcare, housing and quality food, all create the potential for shorter, sicker lives.

What did major public health organizations groups have to say?

"[The proposed rule] grossly overlooks the many longterm benefits of increasing accessing to health care coverage and nutritious foods. If finalized, this rule is likely to result in millions of individuals withdrawing from public benefits programs, including those who are not subject to the public charge test but are fearful that accessing public assistance programs will negatively affect their immigration status. The direct impact and chilling effect of this proposed rule threatens to erode decades of progress made in improving the public's health...At a time when our nation faces a declining life expectancy for the third year in a row, we cannot afford to promote policies that encourage people to abstain from basic health services and limit access to adequate nutrition and housing options."

This will cause many immigrant families to avoid seeking needed healthcare until their condition deteriorates, which could increase avoidable emergency room visits."
